DECISION:

Article 1. Establish Traffic Construction Number 2 Company Limited as a Company's subsidiary with 100% of its Charter capital owned by Saigon Traffic Construction Joint Stock Company, effective **from July 01, 2026.**

9. Repair and maintenance of automobiles and other motor vehicles
Details: 2-wheel and 4-wheel vehicle washing services. Repair and maintenance of automobiles and other motor vehicles (industry code 9531)
10. Architectural activities and related technical consulting:
Details: Consulting for construction of B and C class transportation works, consulting for water supply and drainage works, technical infrastructure, and geological survey for construction. Testing and quality inspection of construction works and materials (industry code 7110)
11. Wholesale of other construction materials and installation equipment
Details: Trading of specialized construction materials and traffic signals. Wholesale of supplies and equipment for the water supply and drainage industry (industry code 4673)
12. Manufacture of other electrical equipment.
Details: Manufacture of traffic signals (not operated at the head office) (industry code 2790).
13. Advertising.
Details: Production of billboards for traffic safety propaganda (not operated at the head office) (industry code 7310)
14. Demolition: demolition of construction works (industry code 4311).

Details: Construction of dredging and water/wastewater environmental treatment works (industry code 3700)

Details: leveling, site preparation (industry code 4312).
